PART 2 PROPOSED WORK PROGRAM AREA AND WORKS COMPONENTS

Please provide the following information with your application. The following list applies to all stages of the proposed works. Some of the information may not be relevant to your application. You will be notified and requested to provide further information if necessary.

- a) A list together with concise descriptions in lay terms of all works components of the proposed works in sufficient detail to assess the likely impacts, including:
 - i) an assessment of the likely level of ground/vegetation disturbance;
 - ii) all locations where any gravel, sand, water and other raw material extraction is proposed (including existing extraction pits);
 - iii) the depth and volume of proposed raw material extraction and the area in square metres/kilometres of the extraction source, including pit extensions.
 - iv) all proposed access routes to other works components, including the length and width of the routes and whether existing or new access tracks will be used.
 - v) any proposed camp sites.
- b) Brief environmental impact assessment to allow further evaluation/monitoring if necessary. Indicate whether the proposed works require a public environmental report or an environmental impact statement under the Environmental Assessment Act.
- c) Rehabilitation plans for all temporary works.
- d) A current 1: 50,000 scale topographic map (or the best large scale map available) clearly indicating the boundary of the proposed work program area An application cannot be processed until a boundary is determined.
- e) The name of the Aboriginal Land Trust or pastoral lease, or lot, portion, section, mining lease or exploration licence numbers relevant to the proposed work program area.
- f) The location (in GPS coordinates, GDA94 datum) and scope (in square metres/metres/kilometres/radius) of all proposed works components and the total proposed work program area encompassing these components.
- g) A plan of the location and scope of the proposed works, including building site plans if relevant, sufficient to determine the 'footprint' of the works components and any service connections within the total proposed work program area. This plan may not be necessary if the proposed works involve widespread and profound impacts across the total proposed work program area.
- h) Additional maps, aerial photos and plans may also be attached to assist consultations with Aboriginal traditional owners.

3. ENTRY ON TO ABORIGINAL LAND

A CLC Sacred Site Clearance Certificate is NOT a permit to enter Aboriginal Land.

Applicants **must** obtain any entry permits required to enter Aboriginal land granted under the *Aboriginal Land Rights (Northern Territory) Act, 1976 (Cth)*. Entry permits are necessary for all works including initial work site visits for the purpose of documenting the proposed work program. IMPORTANT – Applicant's agreement

I agree that if a Sacred Site Clearance Certificate is issued and I carry out the proposed works then –

- (i) I am legally bound to comply with the conditions of the certificate; and
- (ii) if I fail to comply with the conditions of the certificate I may be civilly or criminally liable for entering, damaging, or interfering with, sacred sites.
