## **LEST WE FORGET: CONISTON 1928-2018**



Willowra women and girls danced at the 90th Coniston anniversary commemoration.



Willowra men ended the commemoration with a performance.

After the council meeting delegates travelled to the 90th anniversary commemoration of the Coniston Massacre at Yurrkuru. They joined Chief Minister Michael Gunner, Minister for Aboriginal Affairs Ken Vowles, Commissioner of Police Reece Kershaw and federal MP Warren Snowdon, as well as local organisations and students

from many affected communities. Descendants of the massacre victims and perpetrators agreed that all Australians need to know about the country's violent colonial history. CLC chair Francis Kelly and executive members Teddy Long called for a national public holiday to remember those who died during the frontier wars, similar to ANZAC Day.

## **MEMBERSHIP REVIEW**

Delegates discussed land council membership in each CLC region ahead of next year's council elections. Most regions were happy with how their region is represented on the council but two regions have postponed their decision to the November council meeting.

## NEW MINISTER

Delegates raised concerns about housing, youth detention and roads with the new Minister for Aboriginal Affairs, Ken Vowles. Mr Vowles told delegates he was going to listen and learn and would be a strong voice in cabinet for Aboriginal Territorians. Delegate Sabella Turner criticised moving young people from the Alice Springs detention centre to Darwin. She said the solution is to have children with families in community to get a good education and a job.

## **AHNT MEMBERS TO** PROGRESS HOUSING **REFORM**

Delegates continued to speak up for more houses and better repairs and maintenance. They said the housing crisis affects everything from health to education and employment. They heard that the Commonwealth and NT governments had each committed \$550million over five years, to be distributed under a new national partnership agreement on remote housing from early 2019. The NT government is looking at making remote housing rent fairer and simpler.

Delegate Barbara Shaw discussed new models for community controlled housing the CLC is working on with Aboriginal Housing NT (AHNT) and the NT government. Council nominated five delegates to AHNT: Mathew Palmer, Norbert Patrick, Valerie Martin, Douglas Multa and Kenny Martin.



## **ABA OUTSTATIONS PROJECT UPDATE**

Delegates had lots of questions about the consultation process for the \$15.7 million ABA outstations project, such as who will make decisions on and manage the funds. They were reminded that council resolved in November 2017 that each region will

be involved in decision making and get a fair share of the money. The CLC had begun information meetings, with more meetings still to go ahead. The next council meeting will be asked to make decisions.



## **ROYALTIES IN THE NEWS**

Council discussed negative media coverage about the impact of royalty distributions on the situation in Tennant Creek. Region 6 delegates expressed strong concern about the news reports and said Aboriginal people should not speak for other peoples' country or give misleading information about royalty distributions.

## **POWER & WATER RESPONDS**

NT Power and Water (PAWA) responded to delegates' worries about the water quality and scarcity in their communities. PAWA said it's responsible for the water in 32 communities. In five of them, including Nyirrpi and Willowra, the water does not meet quality standards. It is looking at water pipelines and more bores to increase water supply. PAWA is not responsible for water on outstations, therefore residents need to do their own water testing.

## LAND & SEA ACTION PLAN

The NT government presented 10 action areas under its Aboriginal Land and Sea Action Plan, including land rights, native title, leasing and tenure, sacred sites, parks and economic development. Public servants said nothing will happen until the land councils approve the plan, but delegates want the government to first improve their living conditions and return power back to communities. They also asked how a proposal to allow pastoralists to sublet land for non-pastoral uses would affect native title rights and interests. CLC lawyers are working with the government to make sure these rights are protected.

## WORK FOR THE DOLE SCHEME

Council heard about the federal government's plans to bring in tougher CDP penalties from next year. The CLC policy team said the government had tweaked its top-down scheme a bit but ignored key features of the community-driven model developed with the NT's peak Aboriginal organisations (APO NT). APO NT is part of a national alliance that is lobbying the opposition parties ahead of the coming federal election to support the alternative model.
